ANNOUNCES CHANGE OF STOCK SHORT NAME TO
“NEWAY GROUP”

UPHOLDING ITS PRESENCE IN THE MUSIC AND ENTERTAINMENT BUSINESSES INDUSTRY

(Hong Kong, 13 September 2009) - Neway Group Holdings Limited (“NEWAY GROUP” or the “Group”) (SEHK: 00055) announced that the stock short name for trading of the Group’s shares on the Stock Exchange will be changed to “NEWAY GROUP” (in English) and “中星集團控股” (in Chinese) with effect from 14 September 2009.

Mr. Suet Ka Lun, Ernie, Chairman of the Group, said, “We are very pleased to announce the change of the Group’s stock short name to ‘NEWAY GROUP’, signifying the Group’s business development to the music and entertainment businesses industry. The Group is confident to seize business opportunities arising from the booming business potential of artistes management, music production and/or distribution of music albums and maximize the return to our shareholders.”

Subsequent to (1) the passing of a special resolution by the shareholders at the special general meeting of the Group held on 17 July 2009; (2) the receipt of the Certificate of Incorporation on Change of Name issued by the Registrar of Companies in Bermuda on 23 July 2009 and (3) receipt of the Certificate of Registration of Change of Corporate Name of Non-Hong Kong company issued by the Registrar of Companies in Hong Kong on 26 August 2009, the new name of the Group become effective since 26 August 2009.

The Change of Company Name will not affect any of the rights of the shareholders. Any new share certificates of the Group will be issued in the new English and Chinese names and new logo of the Group from 14 September 2009 onwards. All existing share certificates for shares in issue bearing the previous name and previous logo of the Group will continue to be effective and as documents of title to the shares and will continue to be valid for trading, settlement, registration and delivery purposes. Shareholders may on or after 14 September 2009 until 13 October 2009 (both dates inclusive) submit their existing certificates of the shares to the Group’s branch share registrar in Hong Kong in exchange, at the expense of the Group, for new certificates bearing the new names of the Group.
